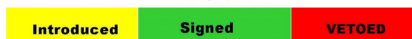

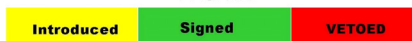

CA	SB 758	Tire Recycling Fee- the California tire recycling act requires a person who purchases a new tire to pay a California tire fee in the amount of \$1.75, of which \$0.75 of the fee is designated for programs and projects that mitigate or remediate air pollution caused by waste tires and the remainder is deposited in the California tire recycling management fund, for expenditure by the department of resources recycling and recovery, upon appropriation by the legislature, for programs related to the disposal of waste tires. After January 1, 2015, existing law decreases the amount of the fee to \$0.75 and provides for the deposit of that entire amount in that fund.
